# MONTHLY REPORT FOR THE MONTH OF NOVEMBER, 2019 SUBMITTED BY DISTRICT LEVEL SPECIAL TASK FORCE

The 16<sup>th</sup> Meeting of District Level Special Task Force was held on 29.11.2019 under the Chairmanship of Additional Deputy Commissioner, U.T. Chandigarh in D.C. Office, Chandigarh to discuss the action taken to control the pollution in river Ghaggar.

#### 1) Status of tenders w.r.t. upgradation of STPs and construction of new STPs.

Sh. Gagandeep Singh, Manager, Chandigarh Smart City Limited, informed that two bids were received by Chandigarh Smart City Limited for up gradation of existing STPs and construction of new STP. Technical evaluation of bids has been completed but objections were raised in the house. However, the details are yet to be received.

He further informed that the timeline for upgradation of existing STPs and construction of new STPs was November, 2021 but now it has been revised to April, 2022.

#### 2) Status of plugging of various points of Sukhna choe and N-choe.

Sh. Vivek Pandey informed the committee that some of the points which were plugged earlier are again found discharging wastewater into the choes. Status of all the discharge points of Sukhna Choe, N-Choe & Faida Choe were discussed. Municipal Corporation, Chandigarh provided the status of discharge of untreated waste water in N-Choe, Sukhna choe and Faida choe which is as given below:

#### 3) Status of health check up camps

Ms. Shobhna Pathania, Nodal Officer, Health Department informed that as per the directions, regular health check up camps are being organized. Last health check up camp was organized on 18.9.2019 at Civil Dispensary, Sarangpur. Due to some technical lag, they did not organize any camp in the month of October and next health check up camp will be organized on 06.11.2019 at Khajehri, Chandigarh.

Sh. Sachin Rana, ADC, UT Chandigarh directed Health department, U.T. Chandigarh to organize health camps with an objective to prevent water borne diseases and the main focus should be on imparting awareness amongst localites.

MC Official suggested Bapu dham colony as a location for next health camp. ADC has also directed CPCC to provide them with the list of locations where Health Department may organize the health camps.

4) Inspection of industries by Additional Chief inspector of factories w.r.t. compliance of the factory rules to provide good environment and healthy condition to the workers of the factories.

Sh. Sushil Dogra informed the committee that the report submitted by the Additional Chief inspector of factories in the meeting of Executive Committee was not satisfactory and he was directed to submit the modified report again w.r.t. observations, action taken, work zone area, display boards, safety gears, chemical storage, air emissions and ventilation etc.

ADC directed to call Additional Chief inspector of factories for the next meeting.

### 5) Regular inspection of industries by CPCC so as to take action against the defaulting units.

Sh. Sushil Dogra informed the committee that inspections of industries are being done regularly and actions are being taken as per the findings. He informed that 13 units were inspected in the month of September. Out of which samples were collected from 10 units.11 units were found to be complying with the standards whereas directions for disconnection of electricity were issued to 2 non- complying units.

In the end ADC directed all the concerned to take action as per the action plan and directions of Hon'ble N.G.T. and Executive Committee.
