

Enclosed please find herewith the minutes/status report of State Level Special Task Force of 6th & 7th quarter for information & further necessary action please.



Minutes of 6th and 7th quarter Meeting of State Level Special Task Force held on 11.06.2020 under the Chairmanship of Worthy Adviser to the Administrator in compliance to the Hon'ble NGT order dated 07.08.2018 in the matter of OA No. 139 of 2016 titled Stench Grips Mansa's Sacred Ghaggar River (Suo-Motu Case) and Yogender Kumar.

6th and 7th quarter Meeting of State Level Special Task Force was held on 11.6.2020 under the Chairmanship of Worthy Adviser to the Administrator in U.T., Secretariat, Sector 9, Chandigarh to discuss the status of action taken to stop the pollution in River Ghaggar in compliance to the Hon'ble NGT order dated 07.08.2018 in the matter of OA No. 139 of 2016 titled Stench Grips Mansa's Sacred Ghaggar River (Suo-Motu Case) and Yogender Kumar. The list of officials/officers who attended the meeting is enclosed as Annexure-I.

Member Secretary, State Level Special Task Force welcomed all the members and gave the presentation in which he informed the present status of waste water discharge points at Sukhna Choe and N-Choe. The details are given below:

1. Status of untreated waste water discharge in sukhna choe and N-choe

Member Secretary, State Level Special Task Force informed that, as informed by the Municipal Corporation, Chandigarh, no sewage water is flowing into Sukhna choe from any of its outlets. Also, no sewage water is flowing into the N-choe from all the outlets except from one outlet i.e. garden of springs where the sewage water is coming from Mohali.

Member Secretary, SLSTF informed that CPCC will inspect the all outlets of Sukhna Choe and N Choe to verify the same.

2. Status of Tenders w.r.t. upgradation of STPs and construction of new STP

Sh. Mukesh Anand, Chief Engineer, Chandigarh informed that Chandigarh Administration will allot the tender for installation of the new STP at Kishangarh before 30.6.2020 and assured that work will be done at the earliest. The Commissioner, Municipal Corporation, Chandigarh also informed that tenders for the up gradation of the existing STPs have been re floated with last date for bid submission as 19.6.2020.

It was informed that due to Covid 19 situation work got delayed. Worthy Adviser to the Administrator directed that work of upgradation of STPs and construction of new STP should be done at the earliest.

3. Status of compliance/non-compliance of existing STPs.

Member Secretary, SLSTF informed that regular monitoring of all the six STPs is conducted on monthly basis in which it has been found that some of the STPs are not meeting with the prescribed standards. Presently, 3 no. STPs (Maloya, Diggian and 3BRD) are complying with prescribed standards in terms of BOD while 3 no. STPs (Raipur kalan, Raipur Khurd and Dhanas) are not complying with the prescribed norms.

Commissioner, MC informed that they have recently taken many steps to improve the quality of treatment and NEERI person are already studying the functioning of STPs so that till the time of upgradation of STPs, quality can be improved by some modifications.

It was also decided that as NEERI person are here in Chandigarh for studying and suggestion for improvement of performance of existing STPs, Engg. Deptt. may contact them to have a look on Sukhna Choe and N Choe so that process of phytoremediation can be taken further.

4. Status of inspection of industries by CPCC and DLSTF

Member Secretary, SLSTF informed the committee that inspections of industries are being done by the CPCC regularly and actions are being taken as per the findings. He informed that DLSTF has conducted 1 field inspection since January, 2020 and action was taken against the 4 no. violating units. He further apprised the members that no field visit could be done during March- April, 2020 due to the nationwide lockdown.

5. Phytoremediation of outlets of Sukhna Choe and N-Choe

Worthy Adviser to the Administrator directed Chief Engineer, Engineering Department, Chandigarh Administration to work out possibility of the Phytoremediation at all the outlets of Sukhna Choe and N-Choe as per the directions of Hon'ble NGT and to contact NEERI person (who are already in Chandigarh to study the performance of STPs) so that they can visit the Sukhna Choe and N Choe and suggest for phytoremediation methodology.

The meeting ended with thanks to the Chair.
