Department, Chandigarh Administration to stop discharge of untreated waste water into Sukhna choe and N-choe is as given below.

2. Non compliance of Sewage Treatment Plants wr.t. discharge standards.

Sh. Vivek Pandey Scientist 'B' CPCC informed that CPCC is monitoring performance of STPs on monthly basis and it has been found that out of 05 STPs only 02 Nos. STPs are meeting with the prescribed standards and 03 Nos. STPs are not meeting.

Sh. Harish Saini, Nodal Officer, M.C informed that they are already in the contact with company which is operating and maintaining the STPs and will take the corrective measures and reply will be provided within 10 days and they also informed that the information related to use of sludge (which is generated during the treatment process) will also be provided within 10 days.

3. Non providing of following information to Executive Committee by Municipal Corporation, Chandigarh

- i) Sh. Rajinder Singh, S.E., Engg. Deptt. Chandigarh Administration has informed that they are going to take up the matter with Civil Wing of Engg. Department w.r.t to setting up the Flow Measurement Device at exit point of drains into River Ghaggar (as per decision taken in 5th meeting of Executive Committee) which will do this job and process may take 2-3 months.
- ii) Municipal Corporation will provide the information w.r.t installation of Electromagnetic Flow Meter (as per decision taken in 5th meeting of Executive Committee) at inlet and out of STPs within 10 days.
- 4. Sh. Gagandeep Singh, Manager Engg. Chandigarh Smart City Limited informed that tender for upgradation of STPs and installation of one no. new STP has already been floated and will be opened on 22.03.2019 and work will be completed as per schedule.

- 5. Sh. Surinder Kumar, SDO, Building Office informed that the information w.r.t. non obtaining sewer connection by industries will be provided by 10.03.2019.
- 6. Ms. Shobhna Pathania, Nodal Officer Health Department informed that the information will be provided within 10 days regarding organisation of health camps.
- 7. Sh. Vivek Pandey, Scientist 'B' informed the Committee that CPCC inspected 26 Nos. of industries and samples were also taken. After analyses, it was found that 04 Nos. of unit were not meeting with prescribed standards. Accordingly CPCC issued show cause notice to all of the units and units have also given their reply. Now, the case has been put up for further action.
- 8. Sh. Vivek Pandey, Scientist 'B' informed the Committee about the status of management of Municipal Solid Waste, Bio-medical Waste and E-Waste in Chandigarh.
